## Editorial Policy

THE GNLU LAW REVIEW, the flagship journal of the Gujarat National Law University, is aimed to provide an interactive and dynamic forum for scholars, researchers, academicians and law students for evincing their stimulating thoughts and ideas so as to provide food for thought to the entire legal fraternity.

THE GNLU LAW REVIEW invites contributions under the following heads:

1. **Comments:** A Comment is a piece of academic writing that is centered around an analysis of a recent case, piece of legislation, law journal article, or law-related book. Comments are significantly shorter than Notes. A comment should not exceed **4000 words** for being considered for publication in the *Law Review*.
2. **Notes:** A Note is a piece of academic writing which discusses and analyzes an original legal issue or problem in some depth. Beyond this very general description, Notes are quite diverse, both in terms of topic and style. Some are doctrinally focused analyses of particular legal questions. Others present normative arguments on how courts or legislatures should analyze a particular problem that they have not yet addressed adequately. Still others are historical or theoretical. What all good Notes have in common is that they are well-written, interesting, and original treatments of legal problems. Most Notes begin their lives as term papers, either for traditional courses and seminars or for directed research. A note should not exceed **7000 words** for being considered for publication in the *Law Review*.

Kindly note that both the Comments as well as the Notes have to be accompanied by an abstract/ synopsis of the submission in not more than **500 words** along with the key words used in the contribution.

### Manuscript Preparation & Submission Guidelines

1. All submissions are required to be typewritten in the font Garamond with 12 points font size, line spacing 1.5', justified.

2. References within the submissions are to be cited as footnotes in the font Garamond, justified alignment and font size 10 points.
3. The citation style to be followed should be in adherence with *The GNLU Law Review Style Guide*.
4. Each submission must include, in one single document:
  - Title page containing the author's profile (name, year of study, institution of study) and the word count mentioned
  - Abstract (not exceeding 350 words)
  - Contributions should not exceed the prescribed word limit.

### **Contributions Evaluation/Review Process**

The contributions submitted towards publication in THE GNLU LAW REVIEW must not have been previously published or currently submitted for publication elsewhere. The contributions shall be evaluated on the basis of originality, innovativeness, clarity and technical correctness. Authors shall solely be responsible for the accuracy of statements in the article. Any unacknowledged reference in the contribution shall amount to plagiarism and would lead to outright rejection.

### **Copyrights**

The contributions presented to and accepted for publication and the copyrights therein shall be the intellectual property of THE GNLU LAW REVIEW. However, in exceptional circumstances the contributions could be published elsewhere with the prior written permission of the Journal Committee.

### **Indemnification**

All contributors by submitting any contribution towards THE GNLU LAW REVIEW agree to indemnify the Gujarat National Law University and THE GNLU LAW REVIEW from and against all claims, suits, and damages based on any claim of copyright infringement or plagiarism or unauthorized use.

### **Deadline**

Notes/Comments are accepted for being considered for publication in the *Law Review* on a rolling basis. However, they are only reviewed throughout the year, after a call for submissions is

notified. The deadline for contributing submissions for the inaugural issue of the *Law Review* is **Friday July 04, 2008**.
