### Administrative Directive

GNLU/AD/ODSW/105

---

The Pool Table facility (“**the Facility**”) shall be used of in strict compliance with the following rules:

1. Any person with a valid GNLU Identity Card is entitled to use the Facility (“**the User**”).
2. The Facility shall remain open from 8:00 am to 2:00 am next day (“**the Access Time**”), notwithstanding the fact that a given day is a holiday as per the GNLU Academic Calendar or is any other University-designated holiday except during vacations.
3. Any User(s) is required to take the prior permission of the Dean Students’ Welfare in order to use the Facility beyond the Access Time.
4. Any equipment, accessories or facilities, including but not limited to chairs, cue stick(s), balls, pool table cover, cue chalk and other things, provided for the Facility shall not be taken outside the room for the Facility (“**the Facility Room**”). Violation of this rule shall result in a fine of Rs.1500 on the User.
5. No food item(s) and/or beverage(s), are allowed inside the Facility Room. Violation of this rule shall result in a fine of Rs.1500 on the User.
6. All Users shall ensure that all electrical appliances in the Facility Room, including but not limited to the air conditioner, tube lights, fans etc. are switched off when not in use, and while leaving the Facility Room.
7. All Users shall maintain discipline and safety while in the Facility Room. All Users shall use the Facility in accordance with the rules of the game, and ensure that no damage is caused to the Facility.
8. Any case of damaged/broken/stolen equipment or accessories shall be immediately reported to the Dean Students’ Welfare for necessary action(s).

9. A committee nominated by the Dean Students' Welfare and a class representative shall adjudicate upon all cases of damage(s) caused to the Facility or any equipment or any accessory in the Facility Room. Compensation for any damage caused by a User(s) shall be recovered as a fine from the User(s) causing such damage. For the purpose of this Rule, the class representative shall be nominated by the Dean Students' Welfare.
10. Notwithstanding any individual action that may be prescribed for violation of a particular rule, non-compliance with any of the rules by a User(s) shall result in the following action(s) imposed by the Hostel Administration:
- i. Infraction #1: Fine of Rs.1500/-
  - ii. Infraction #2: Fine of Rs.2500/-
  - iii. Any additional infractions: Bar on access to the Facility for one academic year.
11. The University, in larger interest, may suspend access or withdraw the Facility, upon recommendation of the Dean Students' Welfare.
12. These rules are subject to amendment and changes from time to time.
